I suspect you have listened to the voicemail message I left for you this morning... I hope you have spoken with Mrs. Purdy and received her explanation regarding not allowing my LCSW to certify my medical leave... Mrs. Purdy informed my LCSW that because I have not been seen "in person" in my LCSW'S Augusta, Maine office that my LCSW is not eligible to certify my medical leave... additionally, I am not able to secure a California-based LCSW's opinion because I cannot claim residency in California which therefore eliminates my eligibility for health insurance or any assistance programs out here... in light of that information, combined with the information that I am in constant regular contact with Suzanne White of Augusta, Maine via telephone, then I would like to know how Mrs. Purdy expects this to get resolved...

Andy,

I feel a bit foolish sending this email to you because I just sent an email to Mary last week with my final change of address because I was anxious about not receiving my income protection check in enough time to cash it before Thanksgiving... However, here I am sending this to you because I need for you to NOT MAIL my income protection check... Instead, I need my father to pick up this check so that he can deposit it into my bank account at the Maine state credit union given that Thanksgiving is this week and my ability to receive this check in California and get it turned into cash before the weekend is a next to impossible task... and as life would have it I need access to that money urgently...

So, my request is that you hold my check there at the MSEA office and I give permission for my father to pick it up so he can deposit it into my bank account back there in Augusta... if the check has already been mailed then please inform me of that also as I will need to keep my eyes peeled for its delivery... also, I need you to understand that if there is anything that I will need to do in order to allow my father to retrieve this check please do not hesitate to tell me... I need to get this check deposited as quickly as possible as time is a critical factor for me in this situation...

I apologize for sounding and sometimes acting like a crazy person but sometimes when lack of money leads to lack of necessities it turns one a bit loony... so, my apologies nonetheless...

I will be calling you as soon as I wake up which is usually around 10-11am your time... however, you are welcome to call me earlier just please remember that your 8am is my 5am ☺ regardless of the time though, I do need to treat this request as an urgent request so if you need to call me please do not hesitate... my father can retrieve this check as soon as it has been created...
