I have a residential account with TWC that I am using to manage my own low-end private, noncommercial mailserver for my own private noncommercial purposes. No other users access my mailserver for any reason and my mailserver has only processed 225 messages in the past 15 days so there is no threat of my mailserver being hijacked for spamming.

My mailserver is configured to fully comply with TWC rules (as found at <http://postmaster.rr.com/rrDynamic> and [http://postmaster.rr.com/mail\\_blocks](http://postmaster.rr.com/mail_blocks) and [http://postmaster.rr.com/mail\\_server](http://postmaster.rr.com/mail_server)) for outgoing private mailservers to relay all outgoing mail through TWC's SMTP server which I have been told is mail.twc.com:587 and which has worked very well on my mailserver for a few months delivering my mail to all of my recipients.

I also have 8 spam filters installed plus grey-listing and auto-ban functions enabled, as well as authentication required for all external sources connecting to an internal mail server.

Basically, my mailserver is not able to be hijacked for spamming purposes.

Additionally, I have never been accused by TWC or any other ISP of sending or allowing spam to be sent from my mailserver since putting my mailserver online earlier this year.

Nonetheless, TWC has issued a PBL Advisory to Spamhaus ZEN and SORBL notifying them that my IP address 76.179.242.42 is a dynamic IP address and therefore my outgoing mail is now being blocked from being delivered to some of my primary recipients.

One of those recipients which is being blocked from receiving my mail is the UNITED STATE DISTRICT COURT for the DISTRICT OF MAINE in my attempt to communicate about an OFFICIAL PENDING FEDERAL LAWSUIT with Docket No. 1:15-cv-382-NT and which Time Warner Cable is DIRECTLY INTERFERING AND PREVENTING me from communicating with the U.S. COURTS FOR OFFICIAL GOVERNMENT COURT PURPOSES.

I recently had to change my email address with the U.S. DISTRICT COURT ELECTRONIC REGISTRATION FILER Unit to notify them that Time Warner Cable is preventing me from communicating with them because I am using my own private mailserver and thus I was required to change my email address on file with the U.S. DISTRICT COURT (to my gmail.com address) so I can continue to communicate with the court about OFFICIAL GOVERNMENT COURT BUSINESS.

I was told by Austin, the Security Operations Supervisor for TWC, that there is no official prohibition by TWC about residential mailservers and there should not be a PBL Advisory issued on my IP address for that reason, but yet there is and it is DIRECTLY PREVENTING ME FROM COMMUNICATING WITH THE UNITED STATES COURT SYSTEM.

For the following reasons, and other reasons not yet articulated, I am hereby demanding that TWC remove the PBL Advisory on IP Address 76.179.242.42 AND STOP INTERFERING and preventing me from communicating with the UNITED STATES GOVERNMENT COURT SYSTEM by preventing me from sending mail from my private mailserver.

I expect an immediate response to my inquiry.

Otherwise, I am fully prepared to file another federal lawsuit against Time Warner Cable for BREACH OF CONTRACT and violation of my rights under the 1st Amendment, at the very least ...

Please respond immediately with a plan to remove the PBL Advisory and all blocks on IP address 76.179.242.42
