As I explained earlier my schedule is a bit unpredictable this month because I have a trial on the trial list for September so I just know that it will happen sometime this month. I will have more information about when it is likely to be as the month progresses.

It would be best if no mention was made of Pine Tree's testing program on the radio because we need to have all promotional materials approved by our grantor, HUD, before being used. And I feel like it's better to be safe than sorry.

To Whom It May Concern:

I'm an attorney at Pine Tree Legal Assistance. I work in our Fair Housing Unit where we do two things: 1) we help people who are being treated differently by landlords because of their race, color, national origin or ancestry, sex, disability, family status (having children), and sexual orientation; and test landlord and property management companies to see if they are subtle discriminating against people for these reasons.

I wanted to know if I could pass information along to your organization about housing discrimination law general and ask your members if they might be interested in helping us with our testing program. Testers are paid a small stipend for each test they complete and they are trained before being given their first test assignment. We need all kinds of people to be testers. Would the Maine Tenant Justice League be interested in this? Please note that I am a temporary employee here at Pine Tree and my time at Pine Tree is done on 9/30 so if you wanted me to give a presentation we'd have to set that up fast as I am not sure of my colleagues' availability once I am gone.
