Hello. GinA here again.

As I sit in this tent in the hot sun shining down on my head and computers without any relief, surrounded by dust, dirt, and disease-carrying insects, I must send this message to emphasize the life-threatening nature of my current situation which was directly caused by David Brennan's actions regarding my occupancy at 2528 West River Road Sidney.

I must also emphasize the aggravation State Farm's claims process is causing my life-threatening situation.

State Farm's inability, or refusal, to provide me with at least a small token payment for my obvious injuries is directly exacerbating those injuries and has directly caused new injuries of my homelessness which is actionable in federal court as a violation of my federal fair housing rights and my rights as a disabled low income woman who has made a valid insurance claim for bodily injuries caused by your insured's negligent violation of the law.

If State Farm had provided me with a small payment by May 20th to keep me off the street I would not be sitting in this hot sun in the middle of the country at least 20 miles from the nearest store without a car, any money or support because I spent all of my money repairing and maintaining my property at 2528 West River Road which **David Brennan is now trying to SELL FOR \$54,000.00!!!**

David Brennan sold the house to me and my deceased housemate **for \$49,000.00 OR BEST OFFER AFTER OUR REPAIRS WERE DEDUCTED FROM THE SALE PRICE!!**

David Brennan has **MADE NO REPAIRS OR IMPROVEMENTS to 2528 West River Road Sidney since November 11, 2014** but he is now trying to sell the property again for \$54,000.00 ???

I suspect David Brennan is going to renege on that sale contract and kick them out under force of an illegal eviction after those buyers make significant improvements just like he did to me this month.

How many times is David Brennan going to sell this property before it is completely repaired by the "buyers" ?

How many other insurance claims and lawsuits will be filed against State Farm for bodily injury sustained by myself and those future "buyers" or "renters" for their similar bodily injuries?

How long will it take State Farm to perform a thorough physical inspection of the property to determine the validity of my claims?

I am in a life-threatening situation which MUST BE at least a partially resolved IMMEDIATELY.

I must find a proper shelter for myself immediately and State Farm must assist my effort to provide safe living conditions for me in anticipation that my claims are valid and highly likely to be paid.

Please communicate with me immediately about helping me to find a safe place to live, at least on a temporary basis.
