Thank you for your quick reply.

I must again emphasize the life-threatening nature of my current circumstances and the fact that the terms of my final settlement agreement will depend upon how many more days I will be living in a tent and the severity of the bodily injuries I am sustaining.

Please be aware I lost 15 pounds from November 11, 2014 through May 2, 2016 due to air-born toxins and other unsafe conditions at 2528 West River Road Sidney.

I have **lost 5 POUNDS since May 20, 2016** because I lack enough food to eat due to my inability to get to a store and my inability to cook the food I do have.

I now stand 5'5" at 95 pounds !!!

Let it be known that my life is in grave danger from unsafe weight loss, total malnutrition and heat exposure, among other dangerous conditions.

I am holding State Farm and David Brennan jointly responsible for all injuries I have sustained since May 20, 2016.

I strongly suggest State Farm expedite this investigation and present me with a reasonable settlement offer within the next 14 days.

If I do not receive a settlement offer by June 14, I will proceed with a federal lawsuit against State Farm and David Brennan jointly for violation of my federal fair housing rights and my rights as a disabled homeless woman as protected by the ADA, FHA, & FHAA.
