To Julia McDonald:

I am struggling to find the right words to describe how extremely betrayed I feel by your gross professional misconduct during my office visits with you for the past 4 years.

Never once did you ever mention to me that you believed I was delusional. You never told me your **true opinion** about my mental status and you never referred me for a psychiatry evaluation to determine if I was truly clinically delusional.

Every time I spoke with you about my teeth and the extensive clinical research I have done, you never told me that you never took the time to read any of that clinical research I gave you on at least two occasions; instead, you relied only on your lack of understanding and lack of due diligence to intentionally, repeatedly and permanently diagnose me as delusional.

You, of all people, should know medicine is a progressive science, not a static one. And you, of all people, should be interested to learn about cutting edge medical breakthroughs that would better serve your patients.

Instead, you quickly, unilaterally and unreasonably decided I was deluded and made a permanent entry in my medical records with your official clinical diagnosis which you know, or should have known, will haunt me every day for the rest of my life.

Your response through the Patient Advocate office about my submitting my rebuttal into my medical records was wholly inadequate and will not repair any of the damage your misconduct has caused me.

When anyone sees your official diagnosis of "Delusional Disorder" in my medical records and my rebuttal about clinical research that even you didn't know

about, whose statement and credibility do you think the reader will believe? The doctor's opinion or the (allegedly) delusional patient's objection?

Your behavior has permanently destroyed my trust in you as a doctor and as an honest, genuine person. For 4 years you have smiled at me and lied to my face by failing to tell me your true opinion about me.


